# The Opportunity

Our opportunity, as a **Leads4Trades** Agent, allows you to create your own repeating, part-time residual income by offering our essential services to local small businesses which pay month after month for our opportunity to help improve their own sales. To you that means you sell once and get paid many times, month after month.

Our Business Model works both locally and nationally, so right now you can be based anywhere in the country and choose where you operate, with no limits throughout England & Wales. It is likely that this will change as we grow, and start to introduce geographical restrictions once we have sufficient Agents on board. At present, however, this is a genuine opportunity to come into this exciting new business right at the beginning.

With hours to suit your lifestyle, you can work from your own home. We provide the service and administration, and you simply provide the Clients. There is no outlay, and no stock. Full training will be provided. We offer an excellent remuneration package based on results. And again (we can't repeat this enough) - you earn every time the Client pays. Sell once, get paid month after month.

#### **About Us**

We are **Leads4Trades.co.uk**. A recent start-up web-based service company which provides small businesses with high quality, locality-specific customer sales leads.

Our leads are special, because they focus on people who have just moved house, and so are more likely to require the services of local businesses for work such as decorating, roofing, double glazing, hairdressing, pet-care, cleaning, etc etc.



Exclusively, through our professional level partnership with the Land Registry of England and Wales, we are able to provide new sales leads within every post code district in England and Wales. What's more, we provide fresh leads every month (over 50,000 in April 2013 alone), so, importantly from an income perspective, we attract recurring payments from those businesses which buy into our service.

In a nutshell, we provide targeted leads for many types of small businesses and companies who rely on householders for their custom. Our unique selling point is that we offer fresh leads, month after month, of local motivated customers who are looking to spend money on services and on their property with local businesses right now.

#### Our business model

As founders of this business we have been following a certain process ourselves to generate regular and repeat business from our own Clients. We have found that this business works well in the local area in which we have been operating, and that we are generating an excellent income stream from our endeavours.

Having proven that the systems we have in place work well, and with our bespoke end-to-end processes now automated, we have decided that the time is right for opening up this opportunity to a **limited number** of individuals across the country. We will provide the support and resources for these individuals to also make this work in the area that they chose to operate, which may or may not be the area in which they live.

We recognise that the business we have established can thrive anywhere within England and Wales. It is not specifically a location-based business, though for some people this might be the model they choose to use. Such national coverage is not something that we are equipped to do ourselves; the scale is too large for one thing. Rather than employing staff directly to achieve this, we have decided to open up the opportunity for other people to represent Leads4Trades as our Agents, but working on their own behalf; on their own Business.

In assisting others to generate a residual, part-time income for themselves, we will actually achieve some of our own stated goals that we defined when we set up this business towards at the end of 2011. Additionally, the growth of the operation that this will provide will lead to true economies of scale for us as a company, which in turn will offset our substantial back-end costs. A true "win-win" opportunity.

#### Our Website

We have developed a website which tells the story of who we are, shows what we offer, and outlines the benefits of our proposition to our Clients – local businesses up and down the country. Once you join us you will have your own personalised website with your own name and contact details on each of our main website pages via your own unique link which you can publicise on your business cards, Facebook page, LinkedIn profile etc. This will ensure that any Clients who join via the website will be linked to you for remuneration purposes.

This is a fully functioning website, SEO friendly (e.g. for "sales leads <town>" on Google we are prominent for most postcode districts across the country) and it is updated regularly with our new summary data feed generated from our back-end systems.

## Our systems

We have developed a sophisticated back-end system which each month takes the raw data we receive from the Land Registry and processes it in such a way that we have instant access to all the address data for that month for any postcode district, ready to send off to our Clients.

All of our web pages are automatically generated and are accessible via the monthly summary page which outlines the number of leads for any area for any given month, e.g.

This links to further pages each of which is a breakdown of each postcode area's data for that month. This is not only a sales page specific to that area, but also doubles as an SEO friendly page for all the towns & villages named within that postcode area, and allows potential Clients to see the impact this may have on the specific areas that they are familiar with.

This page provides a summary of the numbers of addresses. The actual address data is behind our pay wall, so the Client has to pay to receive it. Some sample data (see figure 1 overleaf) shows the actual detail taken from the following page on our website:

#### Address Information

We provide you with address information for all the properties within the Post Code district(s) of your choice which have been recently sold (as reported to Land Registry) during the month in question.

This will either be as printed mailing labels, as below, for you to put on envelopes and send your flyer or sales letter to your prospective customers by post, e.g.: ...

40, HAZELWOOD AVE, EASTBOURNE, EAST SUSSEX, BN22 OSQ

14, ASTAIRE AVE, EASTBOURNE, EAST SUSSEX, BN22 8UN

27, BROOM CLOSE, EASTBOURNE, EAST SUSSEX, BN22 OTQ

... or by email as a list or a CSV file, or on a CD / USB memory stick through the post, so you can process the information yourself, e.g.:

40, HAZELWOOD AVE, EASTBOURNE, EASTBOURNE, EAST SUSSEX, BN22 OSQ 14, ASTAIRE AVE, EASTBOURNE, EASTBOURNE, EAST SUSSEX, BN22 8UN 27, BROOM CLOSE, EASTBOURNE, EASTBOURNE, EAST SUSSEX, BN22 OTQ

Alternatively, we can even generate your mailshots for you - using the latest mailmerge techniques we can add our addresses to marketing materials you supply either electronically or as printed letters etc.

Our Clients want cost-effective leads which offer excellent value for money. Our feedback is great. They want details of people new to their area who need to use their services, so they can get to them before their competitors.

#### **About You**

You will have the ability to represent our business in a professional manner. Moreover, you will have a desire to succeed. You may have a desire for lots of money, or perhaps just an extra £100 per month would be of benefit to you. As such, the business is yours to put into it as little or as much effort as you choose. # The Compensation Plan

Clients pay a fee for their data, and depending on the number of leads they take each month, this will range from £15 to £65. Typically 67% of postcode areas will attract £25-£35 per month, so on average we use a figure of £30 per Client, per month, for our calculations.

Payment to the Agent is made on or around the 20<sup>th</sup> of the month AFTER the Client fee has been received.

The compensation for the Agent takes two parts:

## **New Client Bonus (NCB)**

When a Client joins us, and pays their fee for their address data, then **NCB** is paid to the Agent as a percentage of that initial fee.

☐ Current NCB = 75% of Client fee

#### **Monthly Commission (MC)**

**MC** is paid as a percentage of the Client's fee made on the second and subsequent months, for as long as they continue making payments. This is the genuine residual income that will over time prove very lucrative to the Agent.

☐ Current MC = 45% of Client fee

### **Payment Criteria**

There are specific factors applicable to the payment of Agents' commission, such as reaching an initial minimum level of Clients, and meeting performance targets each month. These targets are not onerous, but are designed into our business simply to encourage constant activity to help the Agent build their business in a systematic manner.

Full details of the compensation plan are contained in our business manual, and this information is available before making your final commitment.

The remainder of the fees goes towards our substantial back-end costs for the data, and its processing, the administration of the system, maintenance of the website, other operational costs and of course the interactions with our Clients.

The level of fees is assessed regularly and is liable to be adjusted up or down as appropriate, given relevant notice.
